THIS DRAWING IS FOR MEMBERS OF ELECTRICAL FEDERAL CREDIT UNION WHO ARE IN GOOD STANDING WITH THE CREDIT UNION AS OF 03/28/2018 AND WHO HAVE COMPLETED OUR MEMBER SATISFACTION SURVEY. NO PURCHASE OF GOODS OR SERVICES OR PAYMENT OF ANY MONEY IS NECESSARY TO BE ELIGIBLE TO PARTICIPATE AND NONE OF THE ABOVE WILL INCREASE THE ODDS OF WINNING.

1. Drawing Sponsor: Electrical Federal Credit Union, 5080 W 60th Avenue, Arvada, CO 80003. Prize is provided by Electrical Federal Credit Union.
2. Eligibility: Drawing is open to members of Electrical Federal Credit Union who are 18 years of age or older, who have completed our Member Satisfaction Survey and who are in good standing with Electrical Federal Credit Union as of 03/28/2018. Any member who has caused a loss to the Credit Union is ineligible.
3. To Enter: Complete our Member Satisfaction Survey between 03/28/2018 and 04/30/2018. The maximum number of entries per member is one.
4. Prizes: There are two prizes, which are a \$50.00 Visa Gift Card. The entry period starts on 03/28/2018 and ends on 04/30/2018. The prizewinner can request to receive their prize by mail, which will be sent to the address the Credit Union has on file via USPS Certified Mail, or the prize can be picked up at the Credit Union by the prizewinner.
5. Winner Selection: The prizewinner will be randomly selected from all eligible entries. The prize drawing will be conducted by Electrical Federal Credit Union on May 1, 2018. Odds of winning depend on the total number of eligible entries received during the entry period. Limit one prize per winner. Any federal, state and local taxes are the sole responsibility of the prizewinner.
6. To Claim Prize: The winner will be notified via telephone or email within three (3) days after the drawing date. Notified winner may call 303-428-5080 or 1-888-428-5080 to claim their prize. If the prizewinner does not accept their prize or if the prizewinner fails to respond after thirty (30) days, another random drawing will be held from the remaining eligible entries and the prize will be awarded to the winner of that drawing.
